4a (Code:) (Expenses \$ 1,356,614. including grants of \$) (Revenue \$) Kids to Kids, our flagship program, reaches out to at-risk children (grades Pre-K to 5th Grade) in low income areas by providing them with new and gently used books to develop their very own "keep at home" library of books to learn from and share with their families. In the twelve months ended June 30, 2009, 254,429 books were placed in the homes of 46,676 children.

4b (Code:) (Expenses \$ 209,829. including grants of \$) (Revenue \$) Breakfast with Books is a family literacy program that helps instill the importance of reading with the children in partnership with their families. This program supplies breakfast, modeled reading, literacy tips, books, raffle prizes and take home activities for low income families to enjoy and learn from on a monthly basis. In the twelve months ended June 30, 2009, 14,275 parents and children participated in this program.

4c (Code:) (Expenses \$ 13,863. including grants of \$) (Revenue \$) Books & Buddies is our reading mentorship program which partners volunteers from senior centers, businesses and communities with the children attending at-risk elementary centers. The volunteers work individually with the students to focus on further developing the child's reading proficiency, comprehension and verbal recitation skills on a weekly basis for 12 week intervals. During the 2008-09 year, this program created 61 partnerships of children and their mentors, both of whom were equally grateful for the experience. 85% of the students demonstrated a reading improvement of 1/2 grade level or higher after being mentored.
